Mrs. Antje Wessels, BMBF delegate, mentioned about funding measures by BMBF and realized projects in the ASEAN region and China which have been operated by German organizations, IBBF, BEX and IBB.

**Factors of funded projects by BMBF and BIBB consulting services.**

The 9 realized projects composed of IBBF- INTVET and BEX- FiVe in Vietnam, IBBF-ProWoThai in Thailand, IBB: WPI in the Philippines as well as 5 projects in PR China composing of IBBF-efach , IBBF-CodeVET, IBB- KoLeArn, IBB: LBZ-JX and IBB- transport which common factors of 9 funded projects were integrated R&D, focusing on future, designing to tackle difficulties at significant levels, collaborating with networks and implementing with German universities and partners.

Dr. Eva Hanau described BIBB roles on supporting consulting services and expertise to the projects on supplier, logistics and technologies for transferring Germany prospect of work other countries. Hopefully, to enhance level of production and service in the upcoming future, is establishing a new corporation in order to increase skill workforce.

Dr. Pakornkiat Sawetmethikul as RAVTE Coordinator, presented RAVTE Research Plan related to RAVTE Strategy Plan which was collected from 12 RAVTE university members in technological and educational domains, to seek funding guideline from BMBF along with 3 research projects in RAVTE Strategic Plan also proposed by RAVTE AB member, Dr.Rolf Gennrich as well.
